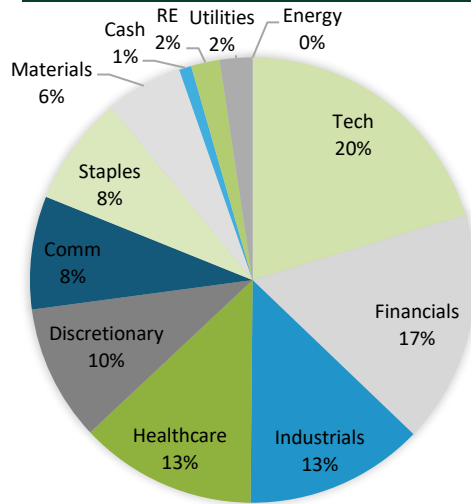

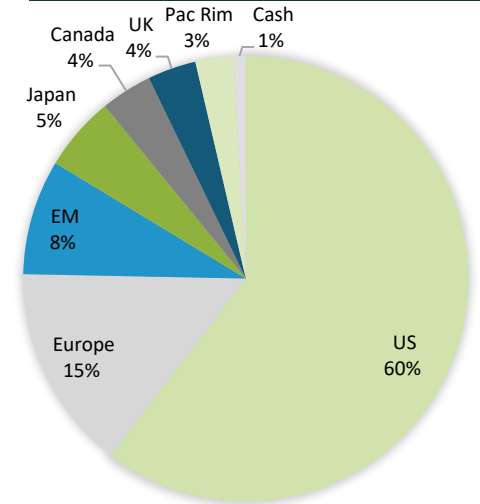

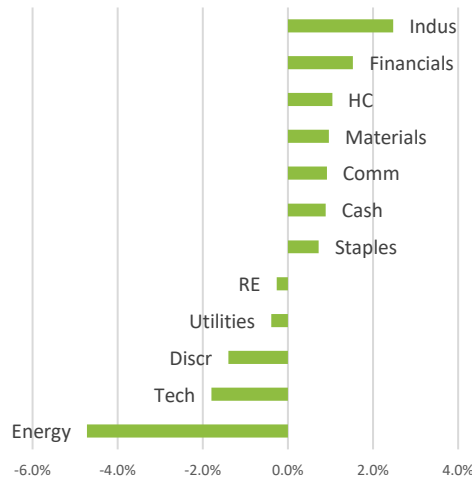
## Sector Composition (%)



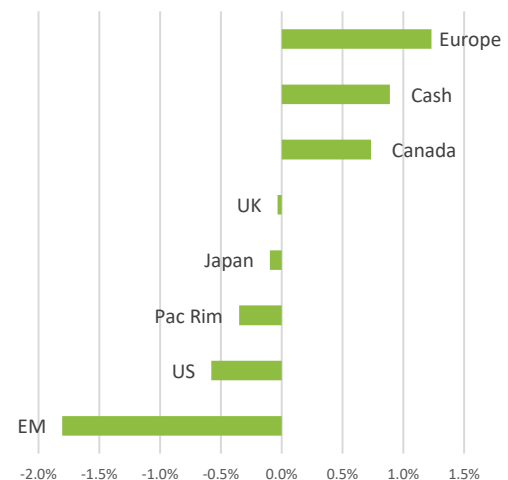
## Regional Composition
